5. Course Information:

a. Course Description: The course will cover various issues of relevance to water resources and water supply management within the Southwest US and other semiarid and arid regions. Discussions may include development and sustainability, climate change and drought, socioeconomic and cultural, and transboundary issues. Student input is encouraged to define discussion topics, which may also mirror student's research areas. Students will also be trained on literature review and citation, research presentation, and the development of research proposals and publications.

b. Prerequisites: -
No specific courses required, but must be graduate student.

c. General Policies: Attendance is mandatory. Class participation is encouraged and may help decide borderline grades. Excused absences require notification submitted to the instructor prior to class. Students will contribute to critical reviews, discussions, literature reviews, discussions, and presentations. Course participants must write an original research paper based on a literature review that is conceptualized, researched, orally presented in class (with feedback from the instructor and fellow students), and finalized as part of the course. Also, the results of their research project will be reported in a proposal (term project).

6. Course Goals:

a. Outcomes of instruction: The primary objective of this seminar is for students to become familiar with current issues and problems facing water supply sustainability in arid regions. Another objective is for students to learn critical thinking, problem solving, and reporting skills. Through discussions, critical reviews, literature review, report writing, and research presentations students to learn research, problem solving, teaming, interpersonal communication, presentation, and reporting skills. An added benefit is the development of written and oral communication skills that will help graduate students complete the degree program in a timely fashion, and help them successfully communicate after completing the degree requirements.

b. Student Outcomes:

- An ability to conduct literature review research
- An ability to develop a research proposal
- An ability to critically review published works
- An ability to engage in discussion and debate

- An ability to communicate effectively (both oral and written)
- The broad education necessary to understand the impact of water resources solutions in a global, economic, environmental, and societal context
- A recognition of the need for, and an ability to engage in life-long learning
- Knowledge of contemporary issues in water resources in the Southwest US and other arid lands.
